Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007.

No. GP-40-MCG/1017/SFS-162/J.- WHEREAS, in Appeal (Civil) No. 5989/1999, Ahmedabad Municipal Corporation and Another versus Nilaybhai R. Thakore and another, the Hon'ble Supreme Court of India has interpreted the rule for Local Student in its judgment dated the 13<sup>th</sup> October, 1999, for admission to Smt. NHL Municipal Medical College, Ahmedabad:

NOW THEREFORE, in exercise of the powers conferred by sub-section (1) of section 20 of the Gujarat Professional Medical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj.3 of 2008) the Government of Gujarat hereby makes the following rules further to amend the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) Rules, 2017, namely:-

These rules may be called the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) (2<sup>nd</sup> Amendment) Rules, 2017.

In the Gujarat Professional Medical Educational Courses (Regulation of Admission in Undergraduate Courses) Rules, 2017, in rule 9, in sub-rule (1), in clause (viii), the following explanation shall be added, namely:-

\*Explanation: Local Candidate means a student who has passed H.S.C. (sic SSC) / New S.S.C. Examination and the qualifying examination from any of the high schools situated within the

Ahmedabad Municipal Corporation limits or as the case may be Surat Municipal Corporation limits and includes a permanent resident student of the Ahmedabad Municipal Corporation Area or as the case may be the Surat Municipal Corporation Area and have acquired the aforesaid qualifications from any of the high schools situated within the limit of Ahmedabad Urban Development Authority Area or as the case may be Surat Urban Development Authority Area."
